Interested bidders shall register in the e-GP system and deposit the cost of bidding document in the above bank.
4. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to Nepal Oil Corporation Ltd. on or before **12:00 hrs of 2075/04/11**.
5. Bids shall be opened in presence of Bidders' representatives who choose to attend on **14:00 hours of 2075/04/11** at the address below.
6. Bids shall be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amount which shall be valid for **30 days** beyond the validity period of the bid. The bid security may either be in the form of a bid-security issued by an authorized A class commercial bank or a bank voucher issued by Rastriya Banijya Bank, Babarmahal. Bid Security document shall be compulsory submitted according to the format provided in the bid document, otherwise the bid shall be excluded from the bid evaluation process.
7. If the last date of the bid submission and opening falls on a public holiday, the following working day will be applicable. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
