2. The **Engineering and Projects Department, “the Purchaser”** invites sealed bids from eligible bidders for the procurement of **Contract stated above under International Competitive Bidding (ICB) procedures.**
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office stated below or can download the document from **www.bolpatra.gov.np.**
4. Bidding document may be purchased on or before **17:00 hrs of 26th April 2016** from the offices stated in the Bidding Document by the interested Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Nepali Rupees **3000.00** in cash or in any form stated in the Bidding Document. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional fee of NRs. **2000.00** or US\$ **20.00.** However, the Purchaser will not be responsible for delay or non-delivery of the documents so sent.
5. Pre-bid meeting shall be held at office stated in the Bidding Document.
6. Sealed Bids must be submitted to offices stated in the Bidding Document on or before **12:00 hrs on 27th April, 2016** . Documents received after this deadline shall not be accepted.
7. Bidders have option to submit the Bids electronically as stated in the Bidding Documents. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO’s website **www.bolpatra.gov.np.** Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

8. Bids shall be opened in the presence of Bidders' representatives who choose to attend **14:00 hrs of 27th April 2016** at the office stated in the Bidding Document. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, amounting to a **NRs 450,000.00 or USD 4500.00** which shall be valid for 30 days beyond the validity period of the bid.
9. In the comparison of Bids, Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the **Bidding Documents.**
10. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
