3. The **Nepal Oil Corporation, “the Purchaser”** invites sealed bids from the interested bidders for the procurement of Contract stated above under **International Competitive Bidding**.
4. To participate in this bidding, the bidders must have been currently operational in the manufacturing industry / fabrication of Aircraft Fuel Bowser for at least 5 consecutive years and Over the past five (5) years as of the date of bid opening must have completed at least five (5) successful contracts of supply and delivery of aircraft refuellers of 12 KL capacity or more.
5. Interested eligible Bidders may obtain further information and inspect the bidding document at the address below during office hour and may download the bidding documents through PPMO’s website, www.bolpatra.gov.np/egp.
6. Bidding documents may be purchased on or before 6thApril, 2018 from the office by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Nepali Rupees 5,000.00 or US\$ 50.00 in cash or in any form stated in the Bidding Document. For the purpose of the fee deposit; Name of the bank: RastryaBaniya Bank, BishalBazar , Office Account no:109006629401, Swift Code RBBANPKA.
7. A Pre-bid meeting which potential bidders may attend will be held at NOC, Babarmahal at 14:00 Hrs Nepal std. time on Date: 23rd March, 2018.
8. Bidders should submit the Bids electronically through www.bolpatra.gov.np/egp as stated in the Bidding Documents. The electronic scanned copy of Bank deposit voucher for bid document fee shall also be required to submit by the bidder at the time of electronic submission of the bids. In the absence of the bank deposit voucher, the bid shall be considered nonresponsive.
9. Bids must be submitted as stated in the Bidding Document on or before 12:00 hrs of 8th April, 2018.
10. Bids shall be opened in the presence of Bidders' representatives who choose to attend 14:00 hrs of 8thApril, 2018 at the office stated in the Bidding Document.
11. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by a bid security of NRs. 2.2 Million or a freely convertible currency in the form of a bank guarantee issued directly by a reputable bank and counter guaranteed by an “A” Class local bank accredited by Nepal Rastra Bank in the form provided in the bidding documents. The Bid security shall be valid for minimum 30 days beyond the bid validity period.
12. Bank Guarantee issued by any finance company in any form will not be accepted.
13. If the specified date for pre-bid meeting, last date of bid purchasing and submission/opening date fall on a Government holiday then the same time of next working day shall be considered for such events. However,

the date for bid submission and opening shall be considered the next working day of last date of bid purchasing. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

14. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
15. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
